## **ITEM 2 - EDUCATION BACKGROUND AND BUSINESS EXPERIENCE**

Hudson Capital Advisory, Inc. is composed of experienced investment professionals possessing a broad range of knowledge within the securities industry. Advisory persons associated with Hudson Capital Advisory, Inc. must possess, minimally, a degree from an accredited college and a minimum of three years of relevant professional experience.

### **Jeremy C. Hudson (Born: 1977)**

Jeremy joined Hudson Capital Advisory, Inc. in 2022 as an investment adviser representative. Jeremy earned a BS degree in finance from the State University of New York at Buffalo. He is responsible for day-to-day client service and portfolio administration. Jeremy oversees the financial operations of the firm. He also is responsible for the operational efficiency of the firm by coordinating project management, company compliance, advertising, and client relations.

As a portfolio manager, Jeremy works with the investment committee to make asset allocation suggestions as well as stock selection suggestions. Jeremy also heads up the review and due diligence of Alternative and L.P. investments. He also works with clients to provide general counseling on financial matters.

Currently, Jeremy is also a principal owner and investment adviser representative of Hudson Advisor Services, Inc. and, since July 2025, a minority owner and investment adviser representative of Miller Gesko, Inc.

Jeremy is a Board Member of the Financial Planning Counselors of Western New York, Past President of the Mid-Day Club of Buffalo, and serves on numerous local non-profit boards.

## **ITEM 4 - OTHER BUSINESS ACTIVITIES**

Jeremy Hudson is also an investment adviser representative of Hudson Advisor Services, Inc., an investment adviser registered with the Securities and Exchange Commission. Therefore, certain clients of Hudson Capital may also be clients of Hudson Advisor Services, Inc., which presents a conflict of interest. In order to mitigate this conflict, Hudson ensures that under no circumstances will a client account be charged a fee by more than one advisory firm. However, clients may have an account for which Hudson Capital receives a fee and have other accounts for which Hudson Advisor Services receives a fee. Hudson Capital has a conflict when Hudson Advisor Services clients invest in Hudson Capital portfolio strategies that have or may have higher fees than Hudson Advisor Services fees. In addition, Hudson Capital has a conflict when a client becomes a direct client of Hudson Capital as the firm receives a direct management fee from the client.

Mr. Hudson is also a minority owner and investment adviser representative of Miller Gesko, Inc., an SEC-registered investment advisory firm located in Buffalo, New York. Because Hudson Advisor Services and Miller Gesko do not have shared clients and because Mr. Hudson's role is limited to providing advice to the Miller Gesko investment committee, this does not present a conflict of interest.

Jeremy Hudson is not actively engaged in any other investment-related business or occupation. Jeremy Hudson is not actively engaged in any other activity that provides a substantial source of income or involves a substantial amount of time.

#### **ITEM 5 - ADDITIONAL COMPENSATION**

Jeremy Hudson does not receive any additional compensation for providing advisory services.
